On 5 February 2018, L.K. Machinery Company Limited ("LKM") as borrower, and the Company as a guarantor, entered into a facility agreement with a group of banks (the "Lenders") for a three-year term loan facilities of up to HK\$372,000,000 and US\$16,450,000 (the "Facility Agreement"). The Facility Agreement imposes certain covenants relating to specific performance of the controlling shareholder of the Company.

The Facility Agreement provides that it would constitute an event of default under the Facility Agreement if (i) Mr. Liu Siong Song (a controlling shareholder of the Company held as to approximately 62% of equity interests in the Company as at the date of the Facility Agreement) and his family (the "Major Shareholders") collectively do not or cease to own, directly or indirectly, at least 40% of the beneficial interest in the Company, carrying at least 40% of the voting right, free from any security; (ii) the Major Shareholders collectively are not or cease to be the single largest shareholder of the Company; (iii) the Major Shareholders collectively do not or cease to not or cease to be the source of the company; (iii) the Major Shareholders collectively do not or cease to have control over the board of directors of the Company; and (iv) Ms. Chong Siw Yin (spouse of Mr. Liu Siong Song) is not or ceases to be the Chairman of the Company.

On and at any time after the occurrence of an event of default under the Facility Agreement which is continuing, the Lenders may declare any commitment under the Facility Agreement to be cancelled and/or declare all outstanding amounts together with interest accrued thereon and all other amounts payable under the Facility Agreement to be immediately due and payable.
